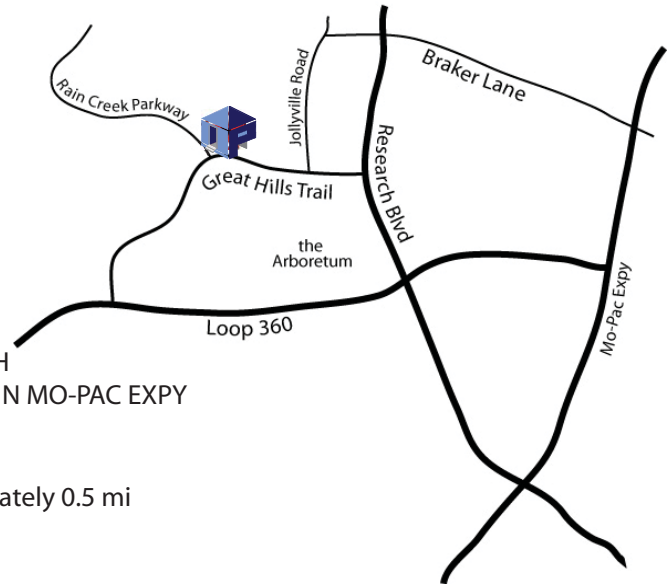


# Patten Law Firm

## Directions to Great Hills Office



### From North Austin

- Take I-35 SOUTH
- Exit #250 onto S I-35 toward FM-1325
- Turn Right on N MO-PAC EXPY
- N MO-PAC EXPY becomes TX-1-LOOP SOUTH
- Take the US-183 N/TX-360-LOOP S exit onto N MO-PAC EXPY
- Turn Right on N CAPITAL OF TEXAS HWY
- Turn Right on RESEARCH BLVD[US-183]
- Turn Left on GREAT HILLS TRL - go approximately 0.5 mi
- Turn Right into GREAT HILLS PLAZA

### From South Austin

- Take I-35 NORTH toward AUSTIN
- Take exit #240B onto US-183 NORTH toward RESEARCH BLVD
- Take the TX-360-LOOP/GREAT HILLS TRAIL/CAPITAL OF TX HWY exit onto RESEARCH BLVD[US-183]
- Turn Left on GREAT HILLS TRL - go approximately 0.5 mi
- Turn Right into GREAT HILLS PLAZA

### From East Austin

- Take TX-71 WEST
- TX-71 WEST becomes BASTROP HWY
- BASTROP HWY becomes US-183 NORTH
- Take ramp onto AIRPORT BLVD toward TX-343-LOOP/1ST-5TH-7TH STS
- Take ramp onto I-35 N toward I-35 N/US-290 E
- Take ramp onto I-35 NORTH
- Take exit #240B onto US-183 NORTH toward RESEARCH BLVD
- Take the TX-360-LOOP/GREAT HILLS TRAIL/CAPITAL OF TX HWY
- Exit onto RESEARCH BLVD[US-183]
- Turn Left on GREAT HILLS TRL - go approximately 0.5 mi
- Turn Right into GREAT HILLS PLAZA

### From West Austin

- Starting at FM-1431 - FM-1431 becomes RR-1431
- RR-1431 becomes W WHITESTONE BLVD[FM-1431]
- Turn Right on BELL BLVD[US-183]
- Continue to follow US-183
- Take the BRAKER LANE/GREAT HILLS TRAIL exit onto RESEARCH BLVD[US-183]
- Turn Right on GREAT HILLS TRL - go approximately 0.5 mi
- Turn Right into GREAT HILLS PLAZA
